

CANDIDATES FOR THE MEMBERS OF THE SUPERVISORY BOARD OF THE BANK

ŽELJKO LOVRINČEVIĆ, Ph.D. (born in 1970), graduated in 1994 and in 2000 was conferred the degree of Ph.D. at the Faculty of Economics and Business of the University of Zagreb – in 1999 he attended the doctoral program at the University of Michigan, USA.

From 1994 Mr. Lovrinčević has been employed at the Institute of Economics in Zagreb where in May 2015 he was appointed senior research associate. From the beginning of his employment until presently, his focus of interest has been associated with the macroeconomic researches, economic policy and system.

He worked on different scientific research projects including the project of the Ministry of Science, Education and Sports – “Macroeconomic convergence of the Republic of Croatia towards the European Union” assessed as one of the most successful among the social science projects.

He has been involved in comprehensive teaching and expert activities, and during different periods of time from 1999 until presently he has been an external lecturer at the Faculty of Economics and Business in Zagreb, teaching at the postgraduate study the courses “Economics of international trade” and “Financial institutions and markets”; Mr. Lovrinčević was an external expert member of the Finance and Central Budget Committee of the Croatian Parliament, lecturer at the International Graduate Business School in Zagreb, International MBA Program, teaching the course in Managerial Economics, he was a member of the negotiating team of the Republic of Croatia for the EU chapter 18, member of the Regional Council for Social Sciences of the Ministry of Science, Education and Sports, member of the Statistical Council of the Republic of Croatia, member of the Economic Council of the Croatian Prime Minister and of the Economic and Social Council, and in the period from 2006 to 2012 he was a member of the Council of the Croatian National Bank; he is occasionally a lecturer at the Zagreb School of Economics and Management teaching the course in macroeconomics, he is a member of the Executive Committee of the Croatian Economic Association, and in 2016 he was the head of the expert group nominated to draft the entire tax reform in Croatia.

Mr. Lovrinčević possesses experience in teaching, consulting and critical reviewing.

He was the winner of the “Gorazd Nikić” Economic Analyst of the Year Award for 2014.

He has an active knowledge of English and passive of German.

MARIJANA VURAIĆ KUDELJAN, M.Sc. (born in 1973), graduated in 1994 from the Faculty of Economics and Business in Zagreb and was awarded the M.Sc. degree in 2004 at the Faculty of Law in Zagreb.

From 1997 to 2002, Mrs. Vuraić Kudeljan worked at the Tax Administration, Regional Office of Zagreb, Local Office of Zelina; in 2002 she started to work in the Central Office of the Tax Administration as an administrative advisor at the Avoidance of Double Taxation and International Cooperation Department and then she worked as an administrative advisor for income tax, property and local taxes; in 2005 she was appointed head of the General Tax Law, Local Taxes and Real Estate Department. From 2009 to 2015, she was the assistant director of the Personal Identification Number Service, then in the Tax System Division and Legislative Activities and Self-Assessment Division.

From January of 2015, she is a deputy director in the Central Office, Director's Office.

She managed different projects, and today she is a member of the working group for the implementation of tax reform, member of the High Valuation Commission in compliance with the Real Estate Valuation Act, member of the working group associated with the projects leading to the modernization of the Tax Administration, member of the General Audit Support Project - GAS Implementation Committee.

Mrs. Vuraić Kudeljan is a member of the Supervisory Board of the Croatian Chamber of Tax Consultants.

She has an active knowledge of English.

MARIJANA MILIČEVIĆ, MEcon (born in 1973) graduated in 1997 from the Faculty of Economics and Business of the University of Zagreb and was awarded in 2000 the degree of Master of Economics.

In 1997 she started to work at the company OMV-Indoil d.o.o. Zagreb where in the period from 2003 to 2005 she was a member of the Sales and Marketing Managing Body. Thereupon, she worked at the company Tisak d.d. Zagreb as a director of marketing. In 2009 she started to work at Hrvatska pošta d.d. Zagreb, first as an executive director of the Network Division and then as an executive director of the Express Division. Since June of 2016, Mrs. Miličević is an executive director of the corporate marketing and development.

As an employee of HP – Hrvatska pošta d.d., she participated in several corporate projects – the creation of strategy of restructuring of the Croatian Post, expansion of service and sale range of retail networks, introduction of sale of banking and insurance services, new visual identity of points of sale, new postal formats adapted to shopping centres, development of package delivery services and expansion of logistic services chain, international agreements on cooperation in the area of express package delivery with the surrounding countries; Mrs. Miličević has gained experience in project management in different companies.
